Code of Conduct

In accordance with our Responsible Behaviour Plan for Students, as a student and parent at Norfolk Village State School we will adhere to:

I am Safe

- ✓ I can self-regulate my emotions and behaviour to model that I'm safe and respectful at all times at events
- ✓ I can be safe and respectful when travelling to and from venues
- ✓ I can look after my wellbeing by eating well, resting and being hydrated
- ✓ I can look after myself and others in my group by committing to the tasks I am asked to participate in
- ✓ I can be safe and set up my equipment (music amplifier, music stand, chairs, books)
- ✓ I can stay in the designated team or area and support other group members during times when I am not participating
- ✓ I can wear the official school/ performance uniform at certain times, as directed by teachers/co-ordinator to represent my school with pride
- ✓ I look after my instrument and place it in a safe space when not playing
- ✓ I will have to pay for damages to my own instrument
- ✓ If I damage another instrument when I have not been safe; I will need to pay the cost

I am Respectful

- ✓ I can support all teacher or parent helper decisions and model respectful behaviour in response to instructions
- ✓ I can be a good group member by encouraging and supporting my team with respectful body/verbal language
- ✓ I can show respect for myself, group members, teacher/coaches, parent helpers, support staff, hospitality staff and group members
- ✓ I can seek help from my teacher, parent helper or supervisor if I am having trouble to regulate my emotions and behaviours; I can ask for help with respect in my voice
- ✓ I can develop positive, safe and respectful relationships with my group, leaders and co-ordinator
- ✓ I can behave in a manner that respects the rights of others regardless of mediums of communication used, always adhering to our school High 5 and High 5 for Cyber safety
- ✓ I can follow all directions of teachers, coaches, support staff, parent helpers, hospitality, co-ordinators and service staff
- ✓ I can take initiative and support my leaders and group members as required
- ✓ I will not be argumentative with my co-ordinator or teacher when I have received explicit instruction

I am a Learner

- ✓ I can calmly select a 'ready to learn' strategy from my plan should I need to and use it safely
- ✓ I can take responsibility for my own behaviour and performance
- ✓ I can listen and show respect during a performance, information talk, demonstration and role play in any given setting
- ✓ I can take on feedback to improve my performance, modelling the behaviours of a learner
- ✓ I can work collaboratively with my teachers/ coaches, parent helpers and service staff to engage in the experience and learn new concepts
